The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault

Minnesota Statute: 609.2242.4, with reference to: 609.2242.4 Maximum Sentence: 5 years imprisonment and/or \$10,000 fine

Offense Level: Felony

Offense Date (on or about): 07/23/2017

Control #(ICR#): 17007320

Charge Description: On or about 7/23/17, within Carver County, Minnesota, defendant intentionally acted with intent to cause fear and/or bodily harm to a family or household member, within 10 years of two or more previously qualified domestic violence related offenses.

STATEMENT OF PROBABLE CAUSE

At approximately 2:22 a.m. on July 23, 2017, the Chaska Police Department responded to a report of a verbal domestic at Patron's Bar and Restaurant located at 207 Chestnut Street in the City of Chaska, Carver County. Officers arrived at Patron's and learned it had closed and no persons were still inside. Officers then learned from dispatch that the caller was now at her home at 2XX East 4th Street in the City of Chaska, Carver County.

Officers responded to the caller's residence and were able to hear what sounded like people struggling on the west side of the residence. As they came to the west side of the house Officer Hance observed a male later identified as Alexis Saborit (DOB 03/30/1979), hereinafter Defendant, was crouched over the reporting party, A.T., and appeared to be holding A.T. to the ground. Officers separated the parties and noted that Defendant smelled strongly of consumed alcohol.

A.T. reported she had been dating Defendant for seven years. A.T. stated Defendant began arguing with her at Patron's because Defendant thought she was talking to another man. When A.T. and Defendant got back to their residence, she tried to exit the entryway to speak with officers and Defendant pushed A.T., causing her to fall and scrape her elbow. Defendant then held A.T. on the ground and attempted to put his hand over her mouth to prevent her from talking to officers.

Defendant was previously convicted of two separate incidents of Domestic Abuse-Battery in Jefferson Parrish, Louisiana with conviction dates of 12/06/2011 in court file numbers 09-6269 and 11-4042.
