COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I**Charge: Obstruct Legal Process-Interfere w/Peace Officer**

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(2)

Maximum Sentence: 1 year in jail and/or a \$3,000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/17/2018

Control #(ICR#): 18024782

Charge Description: On or about 10/17/2018, in Shakopee, Scott County, Minnesota, Alexis Saborit, DOB: 3/30/1979 (39), did intentionally obstruct, hinder, or resist a peace officer engaged in the performance of official duties. Further, the act was accompanied by force or violence, or the threat thereof.

COUNT II**Charge: Fleeing a Peace Officer By a Means Other Than a Motor Vehicle**

Minnesota Statute: 609.487.6, with reference to: 609.487.6

Maximum Sentence: Not more than 90 days jail, a \$1,000 fine, or both

Offense Level: Misdemeanor

Offense Date (on or about): 10/17/2018

Control #(ICR#): 18024782

Charge Description: On or about 10/17/2018, in Shakopee, Scott County, Minnesota, Alexis Saborit, DOB: 3/30/1979 (39), for the purpose of avoiding arrest, detention, or investigation, or in order to conceal or destroy potential evidence related to the commission of a crime, did wrongfully and unlawfully attempt to evade or elude a peace officer, who was acting in the lawful discharge of an official duty, by means of running, hiding, or by any other means except fleeing in a motor vehicle.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

On October 27, 2018, at approximately 11:40 p.m., Shakopee police officers were dispatched to Babe's Place at 124 Holmes Street South, in the City of Shakopee, County of Scott and State of Minnesota, due to a report of a man with a knife who was outside the bar. A physical description of the male was provided, and that male was later identified as Alexis Saborit, DOB: 03-30-1979, hereinafter referred to as Defendant. The dispatcher told the officers that Defendant had tried to start a fight in the bar earlier and had been kicked out.

On arrival officers observed a male matching the description of the person reported to have a knife. Officers approached the Defendant and searched him for weapons, finding a folding knife with a three-inch blade and a kitchen knife with a 10-inch blade. Defendant was placed in the back of a squad car. However, no one at the bar wanted to press charges.

Due to the Defendant's severe level of intoxication, the officers felt he would be unable to care for himself and decided to place a hold on him and take him to detox. When the officers attempted to transfer Defendant to another squad car, he slipped out of his handcuffs and ran from the officers. Officer Filan was the first officer to catch up with him. He grabbed Defendant by his waist and attempted to take him to the ground. Defendant resisted and Officer Filan used a leg sweep to take him to the ground. Defendant was taken back to the squad cars. When the officers attempted to place Defendant in a squad car, he pushed back against the officers, using the force of his body to resist.

Defendant is a 6'00" tall, 154 pound Hispanic male, with hazel eyes and black hair.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.

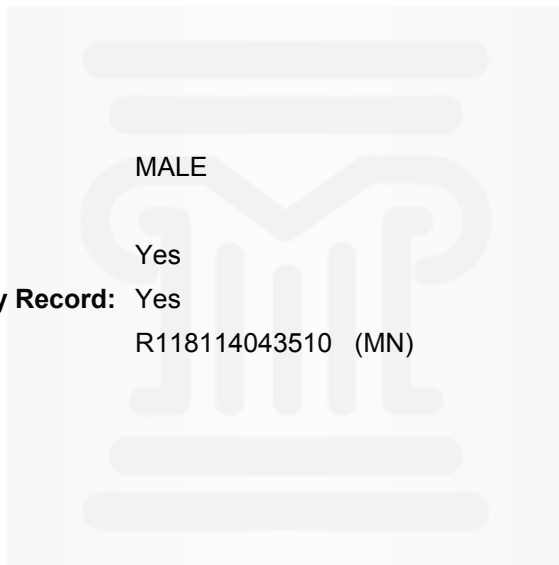

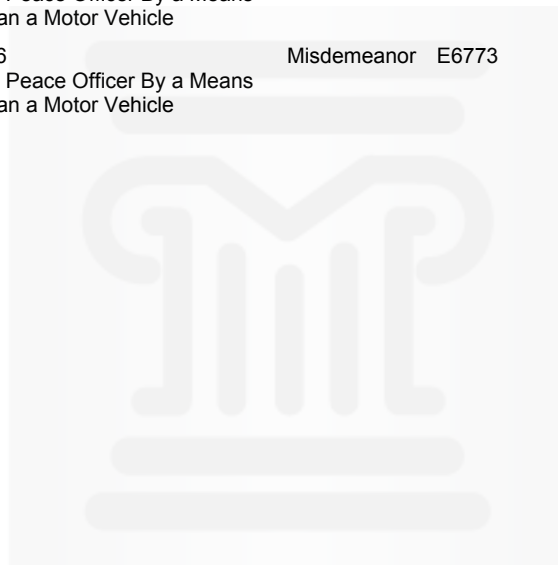
