**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Damage to Property - 1st Degree - Public Utility/Common Carrier**

Minnesota Statute: 609.595.1(3), with reference to: 609.595.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 01/22/2022

Control #(ICR#): 22000463

Charge Description: That on or about 1/22/2022, in Hennepin County, Minnesota, Bel Mbungson Tosah intentionally damaged physical property that belonged to MSP International Airport (victim), a common carrier and public utility without its consent, thereby impairing the service to the public rendered by them.

**COUNT II**

**Charge: Damage to Property - 1st Degree - Value Reduced Over \$1000**

Minnesota Statute: 609.595.1(4), with reference to: 609.595.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 01/22/2022

Control #(ICR#): 22000463

Charge Description: That on or about 1/22/2022, in Hennepin County, Minnesota, Bel Mbungson Tosah intentionally caused damage to physical property belonging to MSP International Airport (victim), without victim's consent and such damage reduced the value of the property by more than \$1,000 as measured by the cost of repair and/or replacement.

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

DUE TO THE BEHAVIOR ALLEGED HEREIN, BAIL IS RECOMMENDED.

On 01/22/2022 at approximately 0404 hours, MSP Airport Police responded to the Terminal 1 Transit Center at the MSP Airport, Hennepin County on a report of a male party breaking things. The suspect was subsequently identified as BEL MBUNGSON TOSAH, date of birth 11/28/1987 (DEFENDANT).

Dispatch advised that DEFENDANT damaged multiple monitors, dumped trash cans, damaged multiple hand sanitizers, and discharged fire extinguishers. DEFENDANT hit a fire alarm box causing the alarm to sound and broke tile behind the alarm.

DEFENDANT was actively discharging a fire extinguisher when approached by law enforcement. When DEFENDANT was arrested, he stated he wanted to go to prison and made multiple statements about raping children. A family was present during the statement. DEFENDANT exhibited aggressive and erratic behavior to law enforcement. Law enforcement unholstered a taser at arrest. DEFENDANT stated, "shoot me."

DEFENDANT's actions were contained on CCTV footage. Damage caused by DEFENDANT includes, but is not limited to: a CCTV camera, a TSA portable workstation monitor, 4 Delta check-in kiosk monitors, a monitor at an information booth, 6 flight display monitors, and the discharge of 2 fire extinguishers.

Damage numbers are being collected, but are believed to exceed \$1,000. The property damaged is part of the MSP Airport.

DEFENDANT initially refused to identify himself. DEFENDANT stated that voices told him to assault children and he caused the damage to make the voices stop.

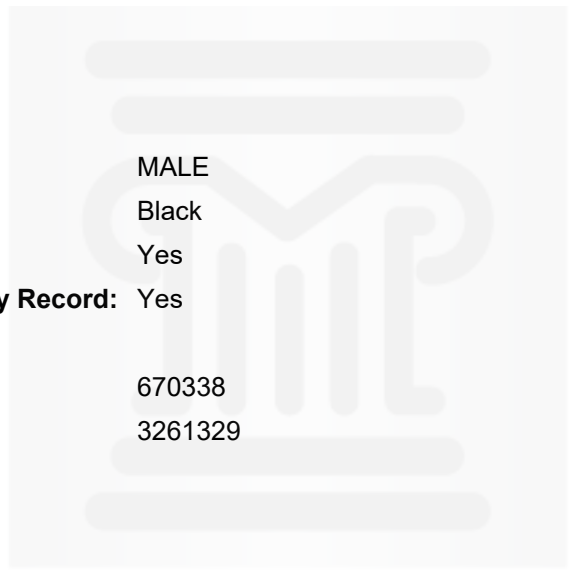

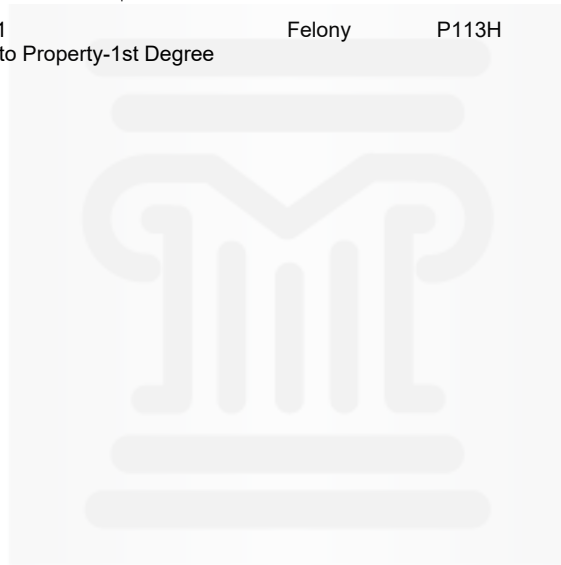
