On 11-10-2022 at approximately 0813 hours, I, Officer / SRO Chris Morgan #5815 with the Isanti Police Department, was notified of a walk-in report involving an incident at the Isanti Intermediate School on 11-9-2022.

I arrived at the Isanti Police Department at approximately 0815 hours. I spoke to XXXXXX XXXXX XXXXXXXXXXXXXXXXXXXX XXX XXXXX XXXXX XXXXXXXXXXXXXXXXXXXX XXXX XXXXXXXXXXXX XXXX XXXXX XXXX XXXXXXXXXXX XXXXXXXXXXX XXXXXXXXXXXXXXXXXXXX XXXXXXXXXXX XXXX XXX XX XXX XXXXXXXXXXXXXXXXXXXX XXXXXXX XXXXXXX XXXXXXXXXXXXXXXXXXXX had made a "murder list" and showed it to XXXXXX. XXXXXX was reported to say to XXXXXX, "This is my murder list, I'm going to kill you"! XXX also was reported to have a google maps location of a newer student who was also on the "murder list".

I was told the list was made during class yesterday and was shown to XXXXXX around 1100 hours. XXXXXX told XXX teacher, Sue Gorka, when XXXXXX left the classroom to go to the restroom. Sue was reported to handle the situation immediately and sent XXXXXX to the Office immediately after getting the information.

XXXXXX stated that XXX name was on it approximately 5 times and several other student's names were on it also. I asked why XXX name would have been on the list, and I was told because XX and other students were "coughing".

XXXXXX stated that she spoke to the Principal, Mark Ziebarth yesterday about the incident and she feels that he is not doing anything about it. She was scared for her child's safety if nothing is being taken seriously.

I explained that I would follow up with Ziebarth and try to figure the situation out. XXXXX wanted to make a complaint against Ziebarth and she was given the option of contacting the Cambridge-Isanti District Office, however I would still be following up with this incident. XXXXX stated that she called and left a message at the district office this morning.

I cleared from the Police Department and went to the Isanti Intermediate School to follow up with Ziebarth.

Ziebarth explained to me that XXXXXX has anger management issues and he has currently suspended XXX until tomorrow pending his further investigation. He continued and explained that he was planning on speaking to several of the students that were on the list. Ziebarth advised the list was on a "white board" on XXX Chromebook and had been deleted right away.

Ziebarth also advised that he had a meeting with XXXXXXXX mother yesterday towards the end of the school day. He said that he was re-assured that XXXXXX does not have any access to weapons that could be brought to school.

At approximately 1410 hours, Ziebarth sent me an email indicating that he has spoken to all of the students involved / impacted and reported the stories all were the same. He will be contacting parents of the students involved as well and advising them the situation has been taken care of.

XXXXX XXX XXXXXX requested this incident be documented at this time in the event something was to escalate at a later time.

I cleared at 1410 hours.
