SENTENCE DETAILS: COUNT 2

Local Confinement

Ordered on November 17, 2025:

- Defendant is sentenced to 90 days in the Hennepin County Workhouse - Adult Corrections.
90 days of that time is stayed for 2 years.
Credit for time served amount is 0.
- Defendant is sentenced to 30 days in the Hennepin County Workhouse - Adult Corrections.
Defendant is to serve 30 days on Home Detention/Electronic Monitoring or Work Release, if eligible.
Credit for time served amount is 3 days.
- If eligible, you are approved for immediate work/school release with furloughs for job-seeking, treatment, and medical care. Furlough 5-8 PM Tuesdays and Thursdays for VETs running group
Start Date: December 01, 2025

Monitoring

Ordered on November 17, 2025:

- Defendant is placed on supervised probation for 2 years, monitored by Hennepin County Community Corrections - Adult Field Services.

Conditions

- No driver license violations
- No driving without insurance

- Concurrent with Count 2.


