**COMPLAINT**

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-3rd Degree-Substantial Bodily Harm**

Minnesota Statute: 609.223.1, with reference to: 609.223.1, 609.101.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 03/18/2021

Control #(ICR#): 21002428

Charge Description: That on or about 3/18/2021, near 78th Street and Nicollet Avenue in Bloomington Hennepin County, Minnesota, MOHAMED ABDIRIZAK RAGE assaulted Victim O.A.O. and inflicted substantial bodily harm.

**COUNT II**

**Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm**

Minnesota Statute: 609.224.1(2), with reference to: 609.224.1(2), 609.101.2

Maximum Sentence: 90 DAYS AND/OR \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 03/18/2021

Charge Description: That on or about 3/18/2021, near 78th Street and Nicollet Avenue in Bloomington, Hennepin County, Minnesota, MOHAMED ABDIRIZAK RAGE inflicted or attempted to inflict bodily harm on Victim 2 F.A.H.

**STATEMENT OF PROBABLE CAUSE**

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 18, 2021, around 2:26 p.m., Bloomington Police Officers responded to a report of a male covered in blood at the Super 8 Hotel located at 7800 2nd Avenue South in Bloomington, Hennepin County, Minnesota. While en route, officers learned that the assault related to this call occurred just down the road on 78th Street. Upon arrival, officers encountered Victim 1 O.A.O., who was holding a towel to his head. Victim 1 had blood running down his face and dripping from his beard. Victim 1 later received medical treatment and was diagnosed with a concussion and a laceration to the head arising from this assault.

Officers also encountered Victim 2 F.A.H. at a nearby gas station. Victim 2 reported that she was walking on 78th Street, just east of Nicollet Avenue South, when she saw a silver Chevrolet Malibu pull up and Defendant MOHAMED ABDIRIZAK RAGE (DOB: 06/07/1997) got out of the car. Defendant was holding a crowbar and began hitting Victim 1 with it. Victim 2 attempted to intervene and Defendant hit her too before getting back into the car and driving away. Both victims also reported receiving threatening messages from Defendant.

Defendant is not in custody and his current whereabouts are unknown, despite law enforcement's efforts to locate him at known addresses. The State is requesting a warrant due to the seriousness of these charges and to protect the victim, witness, and the public from additional harm.

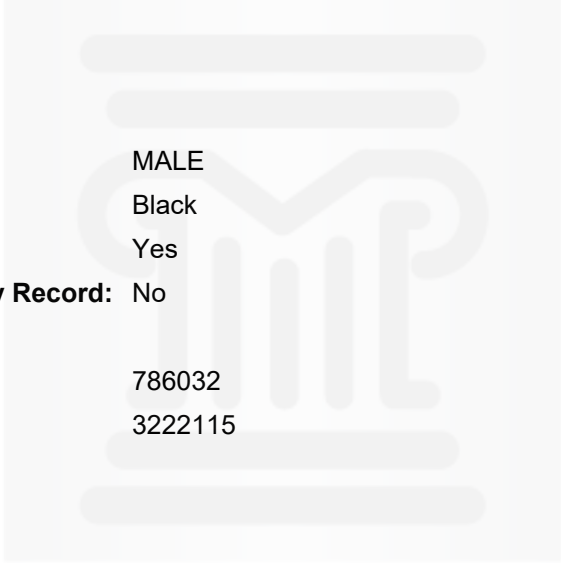
